Precautions for safe handling			
Wear protective gloves/ protective clothing/ eye protection/ face protection. Protect from sunlight. Do not expose to temperatures exceeding 50 °C/122 °F. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Inspect containers for leaks before handling. Label containers appropriately.
